7 8	RESOLUTION OF THE CALIFORNIA HOUSING FINANCE AGENCY FINDING NECESSITY FOR A SPECIAL MEETING UNDER GOVERNMENT CODE
9 10	SECTION 11125.4(a)(7)

12	WHEREAS, The Bagley-Keene Act (Government Code 11120 et seq.) generally
13	requires 10 days' notice before state bodies such as the Board of Directors of the California
14	Housing Finance Agency (the "Agency") may hold meetings; and
15	
16	WHEREAS, actions of the Board of Directors (the "Board") of the Agency may be
17	taken only by a concurrence of a majority of the entire membership thereof, excepting nonvoting
18	ex officio members, pursuant to Health and Safety Code §50914(b); and
19	
20 21	WHEREAS, at the regular meeting of the Board duly called on the 3 rd day of December, a quorum of members was not established; and
21 22	a quorum or members was not established, and
22	WHEREAS, at the regular meeting duly called on the 3 rd day of December, four
23 24	affordable housing projects seeking loans from the Agency (the "Projects") were scheduled to
25	be presented to the Board for their consideration for approval; and
26	
27	WHEREAS, there are various external deadlines for financial transactions of the Projects
28	that need to occur within a time-frame of less than 10 days; and

30	WHEREAS, the Legislature finds and declares that the subject of housing is of vital
31	statewide importance to the health, safety, and welfare of the residents of California

33	WHEREAS, the state of California is experiencing a severe shortage of available
34 35	affordable housing units statewide; and
35 36	WHEREAS, without the Board's immediate consideration of the Projects, harm would
30 37	be caused to the public by preventing the development and preservation of said affordable
38	housing units;

41	NOW, THEREFORE, BE IT RESOLVED that the Board of the Agency hereby:

43	1. FINDS that it must meet on fewer than 10 days' notice to consider action on
44	loans related to affordable housing.
45	2. FINDS the delay necessitated by providing notice 10 days prior to a meeting as
46	required by Government Code §11125 would cause harm to the public interest

1 2 3		and that the immediate action of the Board is needed, pursuant to Government Code $11125.4(a)(7)$, to consider action on loans related to affordable housing.
